The Avi requires a business license for Vendors. Attached is the FMIT Business License Application and Vendor Information form. Return the application with your fees and we will have your license ready upon your arrival. If you possess a 2009 FMIT Tribal Vendor License, please indicate the license number on the first line above.

1. Vendor Hours: Wednesday through Sunday from 9:00am to Dusk. NOTE: Trailer setups begin 8am Tuesday. Tents/ awnings setup after 2pm Tuesday. **All setups on Tuesday & Wednesday! No early setups!**
2. Any balance due must be paid in cash, money order, or credit card prior to setup.
3. Vendor booth must be removed from vendor area on Monday, April 27, 2009.
4. Vendors must supply their own grounded extension cords.
5. All tables, chairs, coverings, decorations, tents or awnings are the responsibility of the vendor.
6. Preference of a booth location is not guaranteed and will be awarded at the discretion of the Avi on a first come first served basis.
7. Power will be shut down at midnight, except food vendor area.
8. Bike displays must be static (no in & out).
9. Must be open no later than 9am daily.
10. No scooters, golf carts, or other motorized vehicles in vendor area from 9am to Dusk except Avi Resort & Casino staff.

11. Fire Lanes to remain clear at all times, vendor displays not to extend in front of booth.
12. Only one business/vendor to a space.
13. Each vendor must provide own means to secure to ground and secure contents from casual theft.
14. All vendor spaces come with outlet for 1-15 amp 115v outlets.
15. All Vendors must abide by FMIT (Ft Mojave Indian Tribe) and the Avi Resort & Casino prescribed policies.
16. Failure by vendor to conform to Rules may result in expulsion from vendor area.
17. Vendors with trailers must include tongue to bumper and any overhangs in measurement.
18. Tents must include all required tie down connection in measurement.
19. No vendors may offer body piercing.
20. Prescribed items. All vendors must abide by AVI's prescribed merchandise policy. The following items are proscribed and may not be sold or even brought upon Avi Resort & Casino property:
21. Air guns, blowguns, explosive devices, crossbows, pistols or other firearms; bayonets, machetes, daggers, switchblades, bowie knives or any other type of knife; sling shots, clubs, spring batons, blackjacks, wood or metal nun chucks or chains; swords (any length) sword canes, spears; any instrument capable of lethal use, possessed under circumstances not appropriate for lawful use; anything lewd or offensive; no drug-related materials and/or any type of drug paraphernalia.
22. Fort Mojave Indian Tribe Regulations: Vendor agrees to comply with the following regulations of the Fort Mohave Indian Reservations: All vendors must be self-contained. Avi Resort & Casino will not loan, rent or provide any equipment. All vehicles must be removed from the exhibit area before the show opens. If not removed, they will be towed at the owner's expense. Electrical power will only be provided in designated areas. Space selection is determined by event and vendors are to stay within their set boundaries. Avi Resort & Casino will not be responsible for lost, stolen or damaged property.
